### Parish Council Meeting

Councillor G.E. Winter took the chair at the meeting of 10th November. Apologies for absence were received from Councillors Cook, Grant and Quarmby. All other members were present.

#### Correspondence

Following approval of the Minutes, various items of information were passed on. Mr. A. Hemingway, Tree Officer for the Borough Council, had written about National Tree Week, 29th November to 6th December. A thousand trees were available, details to follow, and it was agreed to ask for a poster to be displayed in the window of Mr. Bradley's shop.

A poster to be displayed in the Post Office concerned a meeting at the Grand Pavilion, Withernsea, at which the Chairman of the N. Humberside Hospice would describe the present provision and future plans.

The County Council had sent copies of the new bus timetables, operative from 26th October, some of which had been deposited at the Post Office. Two Annual Reports had been received; from the Holderness Borough Council and from the Consumers' Committee of the Yorkshire Water Authority.

#### Planning

Mr. & Mrs. K. Page, North End, Roos, were appealing against the refusal of Holderness Borough Council to give planning consent construction of a bungalow and vehicular access. Opinions from other residents concerning the application were to be sent to the Inspector at Bristol by 26th November.

The Parish Council supported an application by Mr. and Mrs. N. Brocklesby for a rear extension with a flat roof at Manor Cottage, Tunstall (O.S. 101).

At Glebe Farm House, Hilston, outline approval had already been given for a change of use of a farm building to serve as a joiner's workshop (Mr. R.M. Dennis). Listed building consent was also necessary and the Parish Council supported the application.

#### South Park Development

Following the October meeting the Parish Clerk had written to the Director of Development expressing the Parish Council's concern. Members had been anxious that the site plan for three houses with access from Elm Garth might permit at a later stage either an application for two further houses or a through road between Elm Garth and South Park.

Mr. Colin Hogg had replied on behalf of the Director of Development. He said that the developer would not wish to make a through road since it would be of no advantage to him. Meanwhile, the layout of the three houses - in a manner approved in outline in October 1985 - allowed for some of the land to be left as an amenity area. Mr. Hogg asked if the Parish Council would be willing to adopt and maintain this open space.

Councillor Winter said that he had been told by Mr. Hogg - after he had written the letter just summarised - that the developer now proposed to resite the houses so as to incorporate the open space - and leave no amenity area. The plan as now further revised would be available within a few days.

Initially, the Parish Council intended to await written confirmation of this change. However, on Councillor Cheeseman's suggestion, it was agreed that councillors would have a special meeting to discuss the matter as soon as the revised plan was available.

#### Litter Bins

Under 'Any Other Business', Councillor Winter reported that he had asked Mr. Johnson, Environmental Health Officer, about the provision of litter bins in the village. Mr. Johnson had said that the Parish Council must provide them but that, if he were informed of their siting, he would arrange for them to be emptied by the refuse collectors. The Parish Clerk was asked to ascertain the cost of suitable bins.

#### Seating and Flagging

Councillor Priest said that he had looked at a possible site for the seat in memory of the late Mr. Brigham Reed. The Clerk was asked to write to the County Council asking permission to place the seat on the east side of South End Road near Mr. Reed's former house.

Councillor Beal asked whether a flag could not be supplied for the pole at the Memorial Institute. Councillor Winter suggested that Councillor Priest should raise the question at the next meeting of the Institute Committee.

## ROOS F.C. 'A'

Quite easily the most stylish performance of the current campaign was against Thorne Rangers. It was a high class display full of fast flowing entertaining rugby. Once again the experience of Dennis Gale was invaluable and it was him who was instrumental in the defeat of Thorne.

There was better backing up and generally speaking a more professional outlook on the pack. Alan Hampton produced his best performance of the season with some tremendous powerful running. Also to shine, in the centre position, was John Dearing who was playing in his first game for the club.

The other survivor, Arthur Hunt, is living in Withernsea. Most readers will remember John Clark, who farmed at Histon for many years. Ted Scott was a policeman in Withernsea, who mar-

ried the landlady of the Roos Arms. Information about what happened to the others might be interesting.

The photograph was supplied by Mrs. Mary Gee, daughter of Mr. G. W. Wilbraham, for many years schoolmaster in Roos. Mrs. Gee has made available her father's "History of Roos" so that the only known copy can be typed out.
