ROOS VILLAGE PLAN

The Consultative Draft of the Roos Village Plan has been received from

the Holderness Borough Planning Department and copies have been available in village shops from Tuesday, 9th December.

At their meeting of 8th December members of the Parish Council agreed that there should be a Parish Meeting for residents to express their views of the Draft Plan before comments were passed to the Planning Department. The Parish Meeting will be held on Monday, 12th January at 8.00 p.m. in the Memorial Institute. It will be preceded by the normal monthly meeting of the Parish Council which, on this occasion, will start at 7.00 p.m.
The main points in the Draft Plan are summarised below.

Stages of the Plan

The first stage was to consult village opinion. A questionnaire was circulated in the village during November 1985 and the results were published early in 1986. Proposals, which took account of the questionnaire findings, were then presented at a three-day exhibition and public meeting in June. Residents were able to make comments and question the officers of the Borough Council on the issues raised.

The Draft Plan to be discussed at the Parish Meeting on 12th January

constitutes the third and last stage of consultation. The final version of the Roos Village Plan will then be placed before the Borough Council for adoption. A copy will be forwarded to the Humberside County Council for certification that it is broadly in line with the Humberside Structure

Following adoption, the Roos Village Plan will become a working document to be used as a guideline for decisions about housing development and other uses of land in the village up to the year 1996.

The Village Limit

Five main issues were identified, of which the first was the Village Limit. It is proposed to extend the village boundary beyond that established by the former East Riding County Council in the 1960s.

Both the old limit and the new one exclude North End: the limit to the north stops at the new school. (The school is not shown on the maps

supplied, which are based on out-of-date Ordinance Survey maps: some subsequent developments have been added but not all.)
Two changes are recommended:

1. Alteration and extension of the eastern boundary to run in a northerly direction east of Pilmar Lane and west of Eastfield House, then in a westerly direction to Main Street.

2. Extension of the southern boundary beyond Dove Lane to include land to the west of South End Road.

Planning applications in respect of land outside these limits will not be considered unless in connection with agriculture or forestry. Within the limits, applications will be treated on their merits.

Housing

Population in Holderness is expected to grow from the present 47,500 to 52,700 by 1996. The urban settlements - Hedon, Hornsea and Withernsea - will accommodate most of this increase. In addition, 17 selected settle-

ments, of which Roos is one, are expected to grow.

However, housing development in Roos is expected to proceed only at the rate experienced since 1976: an average of 4 houses a year, i.e. an additional 40 houses by 1996. Half of these can be accommodated on sites

either already approved or covered by existing policies.

Land required for the other 20 houses will depend on the assumed housing density. Elsewhere in Holderness the average density is 10 dwellings per acre. In Roos, because of the types of houses built, the density of development has been lower. To preserve the character of the village and to ensure flexibility and choice, the Borough Council is recommended to allow for a continuation of low-density development and to allocate 7 acres of land for the purpose.

Three new sites are considered suitable for development. The map shows the Village Limit and the three new sites - marked A, B, and C.

Site A: East of Main Street, North of Pilmar Lane

Close to village amenities, development would round off this part of the village. It would depend on agreement between the landowners. Access might be from Main Street or Pilmar Lane or both. If both were used, access roads should not be linked as a through road.



Site Area 4.5 acres: Estimated capacity 45 units

Site B: East of Rectory Road

A grassed paddock suitable for low-density housing. Access from Rectory Road. Extension would be possible to the east if the land elsewhere in the village were not released for housing.

Site Area 1.0 acres: Estimated capacity 10 units.

Site C: South of Dove Lane

Former orchard, now overgrown and neglected. Development would enhance the immediate environment. Density recommended: 3-4 per acre. Access perhaps necessary from both Rectory Road and South End Road. Existing mature trees to be maintained as far as possible.

Site Area 2.25 acres: Estimated capacity 6 units

In addition, small infill sites could be developed (too small to be specified here). Applications to be considered on their merits.

Correspondence

Buildings and Trees. The attractive character of the village should be The Elms) the following are being considered for listing: Dents Garth on South End Road and The Bungalow in Lamb Lane. Trees, especially around the church and along Rectory Road, are an attractive feature. The Borough will use its powers to protect trees by making Tree Preservation Orders where necessary. The planting of more trees will be encouraged.

Agriculture. Good agricultural land around Roos is protected from

housing development by the Village Limit. Conversely, residents are protected from the effects of intensive livestock rearing by a wide 'protected area' within which new units or extensions to existing units are prohibited. (The protected area is shown on a map supplied by the Draft Plan.) Local

Footpaths and Open Space. Footpaths should be safeguarded and improved. Verges and other open spaces (e.g. the 'village green' and land at the entrance to the Eastfield Estate) should be maintained and improved. The Borough will liaise with the highways authority (the County Council) to improve the verges.

Traffice Matters

The Borough will bring problems identified by the Village Plan to the attention of the County Council. In particular, the County Council will be urged to establish a speed restriction on the B1242 Hornsea to Withernsea

road, especially in view of the risk to children outside the school.

The Borough will urge the County Council to maintain at a satisfactory standard village roads, footpaths and grass verges that abut highways. The County should investigate and remedy roads that flood after heavy rain,

such as Lamb Lane and parts of Main Street.

To reduce hazards from parked cars, the Borough will consult with appropriate organisations to provide a lay-by outside the school and another outside the Memorial Institute.

Leisure and Recreation

There is no need to allocate additional land. Changing and clubhouse facilities (on the playing field) are desirable. Although their provision is not its responsibility. "The Borough Council would view such ventures sympathetically." Plans to improve facilities in the Memorial Institute were noted with approval.

Other Matters

Local industry is slight (agriculture and service industries). Most people commute to work elsewhere. There is no intention to allocate land for, "existing or possible future firms." However, the Borough will encourage job creation, e.g. the conversion of old buildings into workshops, provided there is no nuisance to residents or harm to the character of the village

Public Utilities

Public utilities, adequate at present, will be kept under review. Sewage facilities are adequate for the foreseeable future.

The Draft Plan contains three maps:

(i) the proposed Village Limit; (ii) the intensive livestock units protected area;

(iii) a large sheet incorporating all the main draft proposals (i.e.: village limit;

existing and proposed housing land allocations; proposed highway improvement scheme and suggested additions; suggested car parking provision;

suggested tree preservation area and authorised tree preservation

proposed listed buildings.

PARISH COUNCIL: DECEMBER MEETING

Councillor K.G. Grant chaired the meeting on 8th December. Also present were Councillors Beal, Cheeseman, Clark, Cook, Priest, Quarmby and Winter.

Minutes

The Minutes of the meeting of 10th November were approved. Under 'Matters Arising', the Parish Clerk passed on details of types of waste bin and was asked to request a current price list and three possible sites for

and was asked to request a current price list and three possible sites for village seats were confirmed.

The Minutes of the Extraordinary Meeting on 19th November were also approved. At that meeting the Parish Council had approved the revised application for the erection of three dwellings at South Park with access from Elm Garth - provided that all the land indicated was used for the three dwellings and that no subsequent application for further building upon it was to be permitted. 'Listed Building' approval had also been given to a revised application regarding the front elevation of Glebe Farm, Hilston.

Draft Register of Electors. The Register had been available for public scrutiny from late November. Forms for notification of corrections were available from the Clerk. The closing date was 16th December.

Proposed Resource Centre in Withernsea. A letter from Mr. Chris Cobley, of the Community Council of Humberside, advised that the possibility of a Resource Centre for the benefit of voluntary groups was being explored. Typing and reprographic facilities would be included. Initial funding would be provided by the Development Commission with possible support (if agreed) from Holderness Borough Council. Parish Councils were being invited to comment. The Parish Council approved in principle

Street Trading. The Borough Council advised that the Local Government (Miscellaneous Provisions) Act 1972 allowed for restrictions on street trading if it might cause traffic hazards or nuisance to residents. It was agreed that there was no need for such restrictions in Roos.

Roos Village Plan. Copies of the Draft Plan were available. Some were to be placed in local shops. The Borough Planning Department had asked for Parish Council comments by 2nd January. It was agreed that a later deadline be requested so that there would be time for a Parish Meeting to

allow residents to express their opinions.

Parish Rate Precept for 1987-8. There had been a request from the Borough Council for an estimate of the likely Parish Rate precept (if any). It was agreed to defer discussion pending an enquiry about responsibility for the cost of a Parish Council Election in May 1987. It was noted that a penny rate in 1985-6 had produced £807. The estimated figure from a penny rate in 1986-7 was £832.

Planning

The Borough Council had approved two previous applications; for a single bungalow at Caer Urfa, Lamb Lane, and for an extension to Manor Cottage, Tunstall. An application for the siting of a residential caravan

east of Coastguard Cottages, Tunstall, had been refused.

East View, South End, Roos. Mr. R. Hinch of Holmpton Road, Withernsea, had applied for outline permission for a dwelling and vehicular access south of East View. Councillors were concerned that there might not be sufficient space for additional access and that the proposed building might need to be set back in such a way that it would overlook adjacent dwellings. They did not support the application.

Eastfield Farm. The Council supported an application by Mr. M. Hodg-

son for permission to erect a house and garage on the farm site to the north of Pilmar Lane.

Accounts

Payment was approved of the account of Mr. C.H. Burn for the provision of two benches at a cost of £212 plus V.A.T. and for the cost of their erection if the work was agreed. It was agreed that Mr. Trevor Uscroft be asked to supply a plaque for one of the benches in memory of the late Mr. Brigham Reed.

Any Other Business

The Chestnuts. Councillor Winter referred to complaints that, in order to achieve access to the site approved for building, trees and the hedge alongside Dove Lane had been damaged. The Chairman had himself spoken with the landowner about these matters. It was agreed that the Clerk should make the following points in a letter to the Borough Council: some young trees had been unnecessarily felled; the hedge had been damaged; the path along Dove Lane had suffered; the landowner should be asked to restore these features.

Nuisance from Motor Cycles. There had been complaints about young motor cyclists causing a nuisance in the village, sometimes as early as nine o'clock on Sunday mornings. They had been riding in various unauthorised areas in the village, including tracks and fields and alongside the Beck on Mr. Reckitt's land at South End. Councillors were sympathetic to the youngsters' wish to have somewhere to ride their bikes but were concerned on several counts: not only at the nuisance caused but also at the fact that some of the riders were under age, probably uninsured and on untaxed cycles, and were often not wearing safety helmets. No decision

In the public session at the end of the meeting, two neighbours expressed their own anxiety at the proposed building south of East View and there were further comments about the damage to the hedge and trees down Dove Lane.



In his Chairman's Report, Mr. Stewart Wilson confirmed the satisfactory year. The main event had been the Fun Day on August Bank Holiday Monday, an undoubted success in spite of unfavourable weather. There had also been the Spring Draw, the Sponsored Family Walk and the Barn Dance. In addition to raising funds, these had contributed to the social calendar of Roos. The Committee's objective was to establish a sporting and recentional base for the village. Manyabile, it was good to see the and recreational base for the village.
